

#### President Joan Asks...

## SHOULD RIVERSIDE LEAGUE CHAPTER FORM A 'SPEAKERS BUREAU'?

I got a timely email from Thea Brodkin, our State League Voter Service Chair. At our recent Board Training Retreat we were talking about forming a local Speaker's Bureau that would be available to local groups for discussion of the pros and cons of ballot measures. It is such a valuable service for the community and really fun once you get all the information under your belt. Plus, the groups that invite us are always appreciative, interested and engaged (and we can charge a small fee for our services).

In the past LWVC posted a document, *In Depth*, six weeks before the election. It contained detailed background information and the pros and cons from every angle about a ballot measure's content. But, that final product was the only source for educating and training League speakers.

Here is what Thea plans to do -

"I am planning to set up a new communication tool to be used by researchers / ballot measure speakers for the June Primary Election. Stacy Shepherd of the Santa Barbara League is working on a "WIKI" to be placed on the LWVC members-only website that will allow us to update the In Depths as new information is gathered and to correct the inevitable errors. As the ballot measure campaigns progress, often there are new pro and con arguments uncovered and we will be able to add them to the In Depths.

In addition, the WIKI will allow League speakers to post articles from their local media and to ask questions. I believe it is imperative that ballot measure speakers have a way to communicate information and have questions answered. We hope to improve the training of ballot measure speakers by having a method of updating material and exchanging information."

Thea has asked for email addresses for those of us who want to participate. I will sign up Helen and me – who would like to join us?

As our initiative process seems to get more corrupt every year by big money and special interests, concerned citizens are really grateful to have the language of the measures explained (as you know, sometimes 'no' means 'yes' and vice versa) and get a clear understanding of the purpose and various ramifications of the measures.

This really is a rewarding task – Let me know if you'd like to sign up.





#### LWVC SETS PRIORITIES FOR 2009

The LWVC Board has adopted the Legislative Priorities for 2009. The priority issues will be State and Local Finances/State Budget -- focusing on reform of the state budgeting process and support of equitable and adequate generation and distribution of tax revenues. As time and resources permit, we will take action on core government issues and ossibler ation in teh areas of Health Care, Water, and Climate Change.

Legislative priorities should not be confused with the issues for Education and ADvocay adopted by delegates to the LWVC Convention. Legislative prioriteis address key issues expected to be active in teh legislature during the current session, and are developed in consultation with LWVC off-board program directors, legislative consultants and legislation committee members.

#### **League Sends First Online Action Alert on Budget Reform**

The LWVC successfully sent its first online ACTION ALERT last month. We asked our subscribers to contact their legislators to demand they get back to work and support real reform through reduction of the two-thirds requirement to pass the budget or raise revenues.

#### California Fair Elections Act

The campaign to pass the California Fair Elections Act (AB 583 of 2008) is building steam. The measure will appear on the June 2010 ballot and would create a pilot project for voluntary public financing for candidates running for Secretary of State in 2014 and 2018. Read LWVC President Janis Hirohama's op-ed in the August 22 Sacramento Bee, linking the dysfunction in state government—evidenced by the budget deal passed in July—with the need for change in Sacramento. As Hirohama put it, "The CFEA is an important first step toward breaking the toxic tie between campaign cash and public policy."

League members and local Leagues can get involved in the campaign, too! We will be adding information to our Government Reform Web page soon, so look for more information in the coming weeks.

#### **Redistricting News**

The draft regulations for formation of the Independent Redistricting Commission called for by last year's Proposition 11 are now posted on the Bureau of State Audits Web site. The League and its coalition partners are working to review the regulations and make comments to the State Auditor's office before the September 14 deadline.

The application period for membership on the commission will open on December 15, 2009 and continue to February 12, 2010. Are you going to apply? Do you know someone who would be a good candidate? Have you asked them yet? Materials will be up on the League's Web site link to redistricting implementation page, to assist you and other prospective candidates in deciding whether to apply.

## PUBLIC OPTION IS ESSENTIAL TO HEALTH REFORM

League Urges Congress and President to Continue Support for Public Option

**Washington, DC** – "The public option in health care reform may not be essential to bureaucrats or insurance companies but it absolutely <u>is</u> essential to the almost 47 million uninsured Americans who live day to day without health care coverage," said League of Women Voters National President Mary G. Wilson. Calling on Congress and the President not to succumb to the bullying tactics being used by special interest groups, Wilson urged Congress and the President not to waver in their support of the public option included in H.R. 3200, America's Affordable Health Choices Act of 2009, recently passed by three House committees.

America is facing a health care crisis caused by a combination of skyrocketing costs and an insurance system that leaves millions of Americans without any coverage. "The current health care system is endangering our economy, our health, and our national security," Wilson said. "Last fall, voters elected a Congress and President that promised to reform our heath care system. Voters made it clear that they want a change in our health care system, a change that puts the brakes on the excesses created by a system dominated by large insurance companies," she continued.

"It is universal coverage that will determine the humanity of our system and a public option will make that possible for Americans who cannot obtain coverage through the traditional employer-sponsored plans," noted Wilson. "We believe that health care reform legislation must guarantee access to comprehensive and essential benefits to all U.S. residents."

"But the possibility of universal coverage is not the only advantage of the public option," warned Wilson. "We must control costs and the public option is the best chance to bring costs into line with reality. As a nation, we are spending \$1 out of every \$6 we earn on health care. Over the last three decades, increases in the amount we spend on health care have consistently risen faster than wages and inflation. Health care reform must provide effective cost controls, equitable distribution of services and allow for efficient and economical delivery of care. Offering everyone the choice of a government administered health insurance plan like Medicare that would compete with private health insurance plans is key to lowering costs."

"The public option is critical to health care reform," Wilson concluded. "Now is not the time for politicians to get cold feet just because a handful of special-interest-backed protesters spread lies and make noise at public forums. Congress and the President need to demonstrate real leadership and move forward with true health care reform."



#### Health Care Reform: League Speaks Out in Support of Public Option

America faces a health care crisis that is endangering both our economy and our health, and business as usual is not an option. The League recently released a statement urging Congress and the President not to succumb to the bullying tactics of special interest groups, and continue supporting the public option included in H.R. 3200, America's Affordable Health Choices Act of 2009.

At a White House press conference recently, President Obama said, "I have great health insurance and so does every member of Congress." It was a reminder that we hear quite a bit about the kind of coverage "lawmakers give themselves."

But what, exactly do lawmakers have in the way of incurance? The LA Times took a closer look at the

insurance? The *LA Times* took a closer look at the taxpayer-subsidized coverage members of Congress have:

- Ten plan choices with access to doctors nationwide.
- HMOs that provide care in each state (in California, there are 11 options).
- Special treatment at Bethesda Naval Medical Center and Walter Reed Army Medical Center.
- For an extra \$300 (House) or \$600 (Senate) per month, access to a Capitol Hill team of doctors, nurses and other medical personnel.
- Three-quarters of premium cost paid by taxpayers.
- Coverage regardless of a preexisting condition.
- No waiting period.
- Under the Blue Cross Blue Shield plan favored by a majority of federal employees, a vast array of medical, dental and vision benefits with \$20 co- payments for doctor visits. Generic prescriptions are \$10 and immunizations are free.
